Ladies and Gentlemen

This Circular provides information on the progress of the SAir,Group debt restructuring liquidation since mid-August 2007:

- I. Publication of supplement I to the schedule of claims and new publication of the schedule of claims for inspection by creditors
- Publication of supplement I to the schedule of claims

The schedule of claims was published for inspection by creditors in October 2006. It had not been possible at this point to make final decisions with regard to all registered claims, which is why certain decisions had been suspended. It has since been possible for conclusive decisions to be made with regard to some of the suspended claims. Supplement I to the schedule of claims of October 2006 will therefore be published.

2. New publication of the schedule of claims

After the schedule of claims had been opened to inspection in October 2006, several creditors lodged actions against SAirGroup to contest the schedule of claims. Many of these actions have since been settled, with SAirGroup recognizing some of the claims that were the subject of actions. A new version of the schedule of claims of October 2006 is to be published to take account of these newly recognized claims.

The claims totalling around CHF 2.9 million that were recognized following legal action to contest the schedule of claims concern claims from former senior SAirGroup executives based on the severance plan. The individual recognized claims are listed in a general notice to the new publication of the schedule of claims. This general notice can be inspected with the new publication of the schedule of claims itself.

3. Inspection by creditors

Supplement I to the schedule of claims and the new publication of the schedule of claims are open to inspection by creditors between 24 October 2007 and 13 November 2007 at the office of the liquidator, at Wenger Plattner, Seestrasse 39, Goldbach Center, 8700 Küsnacht. Please make an appointment with Mr Christian Rysler, on +41 43 222 38 00.

Actions to contest supplement I to the schedule of claims and the new publication of the schedule of claims must be lodged with the single judge in accelerated proceedings at the District Court of Zurich, Wengistrasse 30, P.O. Box, 8026 Zurich, within 20 days of official notice in the Swiss Official Gazette of Commerce announcing that the said documents are open to inspection. The respective official notice in the Swiss Official Gazette of Commerce will be made on 24 October 2007. The 20-day period will thus run until 13 November 2007 (date of postmark by a Swiss post office). If no actions are lodged, supplement I to the schedule of claims and the new publication of the schedule of claims will become final.

WENGER PLATTNER

For each creditor whose claims have been wholly or partly rejected, or not recognized in the class in which they were submitted, a personal notification of the decision with regard to the schedule of claims is enclosed with this Circular. These special notices are in the official German language and will not be translated by the Liquidator into other languages. Legal proceedings in connection with any actions to contest supplement I to the schedule of claims and the new publication of the schedule of claims will also be held exclusively in German.

II. Interim payment

Preparations for the initial interim payment, as announced in Circular No. 12 of 17 August 2007, have been completed. Enclosed with this Circular is the corresponding special notice, which gives more procedural details. Payments will be made from mid-November 2007 at the earliest.
