Dear Sir or Madam,

In the following, I would like to inform you about the conclusion of the debt restructuring liquidation of Flightlease AG.

I. **FINAL PAYMENT**

No complaints were lodged against the final account and against the final distribution list. The final payment could therefore be executed.

All creditors have submitted payment instructions to me. Therefore, all final payments as well as all interim payments could be executed. The estate dividends of CHF 2,904,605.10 attributable to conditional claims (see Circular No. 27, para. IV.) were deposited with the Zürcher Kantonalbank. To the extent that the conditions for the conditional claims do not materialise, a redistribution to the creditors with unconditional claims will be carried out by the competent bankruptcy office in Bassersdorf after the expiry of ten years.

II. FINAL REPORT

My final report on the Flightlease debt restructuring liquidation proceedings from 17 April 2003 until the conclusion of the proceedings has been noted with approval by the creditors' committee. On 17 March 2022, I filed the final report with the probate court at the Bülach District Court. The final report is available to creditors at the liquidator's offices at Seestrasse 39, Goldbach-Center, 8700 Küsnacht, until 25 April 2022 for inspection. In terms of content, the final report essentially equals the content of Circular No. 27 to the creditors dated February 2022. I therefore refrain from summarising the final report below.

III. CONCLUSION OF THE PROCEEDINGS

A) Safekeeping of the Files

The procedural files and the files consulted for the proceedings will be stored under my name at Welti-Furrer AG, Biologiestrasse 13, 8157 Dielsdorf, and kept for ten years. The *Staatsarchiv*, the State Archives, of the Canton of Zurich (hereinafter "State Archives") lays claim to these files on the basis of the Archives Act of the Canton of Zurich insofar as it has an interest in them. In order to meet the requestof the State Archives, the files will be divided into two categories with the assistance of the State Archives. The first category will be handed over to the State Archives after the 10-year retention period has expired. The second category will be decimated the end of the 10 years.

B) Conclusion of the Proceedings by the Probate court and Deletion of Flightlease from the Commercial Register

The probate court will verify, on the basis of my final report, whether all assets of Flightlease have been liquidated and if the liquidation proceeds have been distributed among the creditors. If the probate court reaches this conclusion, it will close Flightlease's debt restructuring liquidation proceedings.
